3. Payment.

- A. DEEP hereby agrees to provide the Services for a fee of \$\_\_\_\_\_ (the "Fee").
- B. Of the Fee, Client shall pay a refundable / non-refundable deposit (circle one) in the amount of \$ \_\_\_\_\_ upon signing of this Agreement (the "Deposit").
- C. Two weeks prior to the Event, Client shall pay at least one-half (50%) of the Fee stated in Section 3(A).
- D. Upon completion of the Event, Client shall pay the remaining balance due of the Fee stated in Section 3(A) less the amount of the Deposit stated in Section 3(B).
- E. If Client wishes DEEP to extend its services beyond the time listed in Section 2, an additional charge of \$\_\_\_\_\_ per hour shall be due upon completion of the Event.
- F. All payments shall be made payable to Direct Effect Entertainment Productions.

4. Cancellation of Services. In the event that Client cancels DEEP's services, the Client shall remain obligated to pay the Fee in accordance with the following unless other arrangements are made in writing between the parties:

<b>Date of Cancellation</b>	<b>Percentage of Fee to be Paid to DEEP</b>
Three or more months prior to Event	0% of Fee due
Two to Three months prior to Event	50% of Fee due
One to Two months prior to Event	75% of Fee due
Less than One month prior to Event	100% of Fee due

5. Rescheduling of Services. A charge of \$75.00 shall be due if the Client reschedules an Event less than one month prior to the original date of the Event.
